HOW ONE & SUN WORKS

After an eligible DeltaVision® member completes their eye exam, they will receive a redemption code in the mail for their free sunglasses within six to eight weeks of their claim.

Once members receive their code, they can redeem it at oneandsun.com. They can pick any brand or style currently on the site, and new styles are regularly added. The glasses will ship directly to the member after the order is placed. Prescription sunglass lenses are not currently covered as part of the One & Sun program.

Members can receive one pair of sunglasses every two years,[†] in addition to their regular vision benefits for prescription eyeglass lenses and frames. Members must remain on the

DeltaVision — 150 Plus One & Sun plan to receive sunglasses in future years.

Codes must be redeemed within 90 days. If a code is not redeemed, the member will be eligible to receive a new code the following benefit year. If a pair of sunglasses arrives damaged, the member will not be charged for the exact same replacement pair.

One & Sun rewards members for preventive eye care visits, and is another great reason to offer DeltaVision!
